WHILE A COUPLE HAD STAFF MEMBERS LAYING ROSES ON FATHERS' DAY OR LAYING CANDLES ON AGENT ORANGE AWARENESS DAY, LARGE CROWDS OF VETERANS AND OTHER VISITORS WERE NOT ALLOWED TO GATHER AT THE MEMORIAL. THE ORGANIZATION PIVOTED QUICKLY, AND USING ONLY INTERNAL STAFF, WAS ABLE TO PRODUCE NINE VIRTUAL EVENTS. WE TOOK ADVANTAGE OF INTERNET CAPABILITIES TO INCLUDE ASPECTS WE NORMALLY COULDN'T DO AT IN-PERSON EVENTS, LIKE A TRIBUTE TO MILITARY WORKING DOGS THROUGH INTERVIEWS WITH THEIR HANDLERS. AS A RESULT, MORE PEOPLE WERE ABLE TO BE A PART OF OUR VIRTUAL EVENTS THAN NORMALLY WOULD ATTEND IN-PERSON CEREMONIES.
